

Cycling is a broad church – the breadth of different disciplines, performance, commuting, health, major events – give huge opportunities and also tough resource challenges. Clubs (and established groups) are critical to the future, but the sport has to recognise and embrace change. As the Scottish rep on the British Cycling Board, I am closely involved with programmes of change but seeking to preserve the traditions whilst also welcome greater opportunity, diversity, and make it easier for people to take up cycling and enjoy the "sport" aspect.

Scottish cycling "punches above its weight" in many ways (compared to the rest of the UK). That doesn't mean we can't do things better however, and as a director l'm committed to listening, and enabling the right conversations around strategy, prioritisation, resourcing.

I chair the Performance & Coaching Board Sub-Group and through that have a close dialogue regarding performance and supporting the staff team focus on the opportunities offered by Glasgow 2026. That is an opportunity for the sport across Scotland and whilst our athletes will inspire, we must capitalise on it for the benefit of clubs, events and our own strategic priorities.

I hope to continue this work and in doing so challenge and support the Exec team, my fellow directors, British Cycling and our partners / stakeholders to ensure cycling in Scotland remains prominent, successful, and offers opportunities to all in a safe, enjoyable manner.
